PTP currently offers 14 berths over 5.04km of linear wharf length and associated container stacking yard area. PTP wishes to invite qualified and experienced contractors with proven expertise to participate in a Pre qualification exercise as described below: .

### **CONTRACT FOR SCRAPPING OF QUAY SIDE CONTAINER CRANES AT PELABUHAN TANJUNG PELEPAS (PTP)**

#### **PROJECT OVERVIEW**

PTP intends to scrap a number of its existing Quay Side Container Cranes (“QC”) which were delivered to PTP Phase one (1) wharf in 2006 namely IMPSA B crane through an “as Is where Is” basis in line with PTP’s long-term business development plan as well as asset replacement policy. The works is expected to commence from 2022 and will be executed based on the best methodology and practices to ensure that QC are safe for removal accordance with the Malaysia regulations.

The scope of works to be carried out includes the following:

1. Up to 3 units Super Post Panamax class container crane are to be scrapped from PTP premises.
2. The major scope of work entails dismantling, removing and transporting the cranes from the quay.

#### RINGKASAN PROJEK
